# Statutes amending the Study and Examination Regulations for the Master programme M.Sc. Artificial Intelligence of the Faculty of Computer Science at Technische Hochschule Ingolstadt

# From 06.11.2023

Based on Art. 9 sentence 1, Art. 80 para. 1 sentence 1, Art. 84 para. 2 and para. 3 as well as Art. 90 para. 1 sentence 2 of the Bavarian Higher Education Innovation Act (BayHIG) of 5 August 2022 (GVBI. p. 414, BayRS 2210-1-3-WK), as amended, Technische Hochschule Ingolstadt issues the following statutes:

#### § 1

The academic study and examination regulations for the Master programme M.Sc. Artificial Intelligence at the Faculty of Computer Science at Technische Hochschule Ingolstadt dated 07.02.2022 are amended as follows:

1. <u>In the title, the words "Künstliche Intelligenz" are replaced by the words "Artificial Intelligence".</u>

### 2. The previous preamble is replaced as follows:

"Based on Art. 9, Art. 80 para. 1 sentence 1, Art. 84 para. 2 and 3 and Art. 90 para. 1 sentence 2 of the Bavarian Higher Education Innovation Act (BayHIG) of 5 August 2022 (GVBI. p. 414, BayRS 2210-1-3-WK), as amended, Technische Hochschule Ingolstadt issues the following statutes:"

#### 3. § 1 is amended as follows:

- a. The words "of the Framework Examination Regulations for Universities of Applied Sciences (RaPO) of 17.
  - October 2001 (GVBI p. 686, Bay RS 2210-4-1-4-1-WFK) and" are deleted.
- b. The words "25 July 2011 a s amended" shall be replaced by the words "17/07/2023 in the respective valid version".

## 4. § 2 is amended as follows:

- a. In para. 1 sentence 1 and para. 2 sentence 1, the words "Künstliche Intelligenz" shall be replaced by the words "Artificial Intelligence".
- b. In paragraph 3, the word "Deutsch (German)" shall be replaced by the word "English".

## 5. § 3 is amended as follows:

a.	
	"(1) Qualification requirements for admission to the Master's degree programme are

- a) proof of successful completion of an academic study programme at a German university with at least 210 ECTS credit points or equivalent in the field of Artificial Intelligence, Data Science, Computer Science, Mathematics, Engineering Sciences, Computational Linguistics or a related field or an equivalent successful domestic or foreign degree and
- b) successful participation in an aptitude test; further details are regulated by the statutes on the aptitude test for the Artificial Intelligence master programme at Technische Hochschule Ingolstadt dated 6 November 2023, as amended."

# b. Paragraph 2 is amended as follows:

- aa. After the paragraph designation "(2)", the sentence numbering "1" inserted
- bb. The sentence numbering "2" is inserted before the words "If none".
- cc. The sentence numbering "3" is inserted before the word "internship".

# c. Paragraph 3 is amended as follows:

aa. In sentence 1, the sentence numbering "1" is inserted after the paragraph designation "(3)".

inserted.

bb. in sentence 2, the sentence numbering "2" is inserted before the words "If the proof is provided in accordance with" and the words "para. 1 lit. a) sentence 1" are replaced by the words "para. 1 sentence 1 lit. a)".

# d. Paragraph 4 is amended as follows:

- aa. In sentence 2 as well as in sentence 3 lit. a) and lit. b), the words "lit. a)" shall be inserted after the words "para. 1 sentence 1".
- bb. in sentence 4, "Art. 63 para. 1 BayHSchG" is replaced by "Art. 86 para. 1 BayHIG".
- e. In para. 5, the words "para. 1 lit. a) lit. b)" are replaced by the words "para. 1 sentence 1 lit.
  - a) and lit. b)" shall be replaced.

#### 6. § 4 is deleted.

# 7. The previous § 5 becomes § 4 and is amended as follows:

- a. Paragraph 3 is amended as follows:
  - aa. After the paragraph designation "(3)", the sentence numbering "1" is added inserted.
  - bb. the sentence numbering "2" is inserted before the words "The details".

b. Paragraph 4 is amended as follows:

- aa. After the paragraph designation "(4)", the sentence numbering "1" is added inserted.
- bb. the sentence numbering "2" is inserted before the words "The details".
- 8. The previous § 6 becomes § 5.
- 9. The current § 7 becomes § 6 and in para. 3 the word "English" is replaced by the word "German"
- 10. The current § 8 becomes § 7 and in para. 2 no. 9 the words "in a foreign language" are replaced by the words "not in English".
- 11. The current § 9 becomes § 8 and in para. 4 the words "General Examination Regulations of the Technische Hochschule Ingolstadt" is replaced by the words "APO THI".
- 12. The previous § 10 becomes § 9.
- 13. The previous § 11 becomes § 10 and is amended as follows:
  - a. In para. 1 sentence 1, the words "General Examination Regulations of Technische Hochschule Ingolstadt (APO THI) in the respective version" are replaced by the words "Annex to the APO THI".
  - b. In para. 2, after the words "in accordance with the" the words "Annex to the" inserted.
- 14. The previous §§ 12 and 13 become §§ 11 and 12.
- 15. The annex to the academic study and examination regulations for the master programme of the Faculty of Computer Science M.Sc. in Künstliche Intelligenz at Technische Hochschule Ingolstadt is amended to the annex of this amendment statute.

These amendment regulations come into force on 1 March 2025. It applies to students who begin their academic studies on this study course in the first study semester from summer semester 2025.
